**Health Clinic:**

- Overall we did:
  - HEARTS:
    - Auscultations 17 tested
    - Echoes 35 tested
      - 15 were member's dogs
  - Eyes:
    - OFA 75 testes
    - Glaucoma: 2 tested
      - 28 were member's dogs
- That is a 19% decrease in dogs seen for heart testing (due to a 54% increase in echo's, and those appointments taking more time) as well as a 45% decline in eye testing, due to another event for CERF exams the same weekend.
- While we are still finalizing the costs of the clinic, but are expecting to be self sufficient again this year
